2018-2019 Selective Service Registration

Most male students must register with the Selective Service System to receive federal aid. Selective Service did not confirm you are registered with the Selective Service System. Please complete the form below and provide documentation if required.

I am 18 to 25 years of age and required to register with the Selective Service System:

- I will register online at www.sss.gov and submit proof of registration to the Financial Aid Office.

I am NOT Required To Register with the Selective Service System:

In order to receive financial aid, you must prove one of the following situations applies. Please check the appropriate statement and provide documentation:

- I was not 18 years of age when I completed my FAFSA.
- I am female.
- I was born before 1960.
- I am a transgender male who was assigned the sex of female at birth.
- I am currently in the armed services and on active duty in the U.S. Armed Forces. (This exception does not apply to members of the Reserve and National Guard who are not on active duty.)
- I am a non-citizen who first entered the U.S. after I turned 26.
- I am a noncitizen who entered the U.S. as lawful nonimmigrant on a valid visa and remained in the U.S. on the terms of that visa until after I turned 26.
- I am a citizen of the Republic of Palau, the Republic of the Marshall Islands, or the Federated States of Micronesia. (A citizen or national of the Republic of the Marshall Islands, or the Federated States of Micronesia who lives in the United States for more than one year for any reason except as a student or employee of the government of his homeland must register.)

There are certain less common situations in which registration isn't necessary. Students who weren't required to register prior to meeting one of the following criteria and who met a criterion for the entire time through the age of 25 qualify for the waiver if:

- They are unable to register due to being hospitalized, incarcerated, or institutionalized;
- They are enrolled in any officer procurement program at The Citadel, North Georgia College and State University, Norwich University, Virginia Military Institute, Texas A&M University, or Virginia Polytechnic and State University; or
- They are commissioned Public Health Service officers on active duty or members of the Reserve of the Public Health Service on specified active duty.

I was required to but did not Register with the Selective Service System:

Students who are not clearly exempt from the registration requirement must provide a statement of explanation of nonregistration and a *Status Information Letter* from Selective Service (www.sss.gov). NCC Financial Aid may require more information from you and will make a determination on your eligibility after a review of all the information.
